I am aware that by completing this form, I also agree to the Regular giving commitment outlined below.

Rosies commitment to me

- Personal information Rosies will aim to ensure that all of my personal information, including credit card details, are kept confidential.
- Automatic payments Rosies will aim to ensure the terms of the automatic payment arrangements as signed by me. Rosies undertakes to debit my nominated debit/credit card for the agreed period and will ensure the first drawing will occur on the date I have requested. The second and subsequent drawings will also occur at the frequency requested.
- Consolidated receipt Rosies will ensure, regardless of my payment method, that I am sent an end of financial year consolidated receipt in a timely manner.
 Deductions over \$2 are tax deductible.

My commitment to Rosies

- Making changes I will aim to ensure that I contact
 Rosies at least five (5) business days prior to the
 next due date of my gift if I want to make any
 changes. These changes may include, but are not
 limited to, deferring the drawing, altering the
 frequency, altering the amount, stopping an individual
 debit, changing debit/credit card details, or cancelling
 the payments completely.
- Communications I will aim to ensure that I include my full name and email address, and will not send debit/ credit card details via email, in all communications to Rosies.
- Sufficient funds and account details I will aim to ensure that there are sufficient cleared funds in my nominated debit/ credit card on the drawing date. I will advise Rosies if my nominated account is transferred or closed. If an automatic payment item is returned unpaid by my financial institution, due to insufficient funds, Rosies will contact me for permission to resubmit.
- Cancellation of payments I understand that Rosies reserve the right to cancel my automatic payment if two (2) or more automatic payments are returned unpaid by my financial institution. Rosies will attempt to contact me by telephone and/or email to arrange an alternative payment method or updated/new debit/ credit card details.
- Incorrect payments I will contact Rosies if I believe that a drawing has been initiated incorrectly. If I do not receive a satisfactory response from Rosies, I will contact my financial institution who will respond to me with an answer to my claim and may in turn contact you. I will receive a refund of the drawing amount if Rosies cannot substantiate the reason for the drawing.
